#### **About PHC4**

The Pennsylvania Health Care Cost
Containment Council (PHC4) is an independent
state agency charged with collecting, analyzing, and
reporting information that can be used to improve
the quality and restrain the cost of health care in the
state. It was created in the mid-1980s when
Pennsylvania businesses and labor unions, in
collaboration with other key stakeholders, joined
forces to enact market-oriented health care reforms.
As a result of their efforts, the General Assembly
passed legislation (Act 89 of 1986) creating PHC4.

PHC4's primary goal is to empower purchasers of health care benefits, such as businesses and labor unions, as well as other stakeholders, with information they can use to improve quality and restrain costs. More than 840,000 public reports on patient treatment results are downloaded from the PHC4 website each year. Additionally, nearly 100 organizations and individuals annually utilize PHC4's special requests process to access and use data. Today, PHC4 is a recognized national leader in public health care reporting.

PHC4 is governed by a 25-member board of directors representing business, labor, consumers, health care providers, insurers, and state government.

#### **Foreword**

On an annual basis, the Pennsylvania Health Care Cost Containment Council (PHC4) produces a series of reports measuring the financial health of Pennsylvania's hospitals and ambulatory surgery centers.

This is the second volume of a three-volume series of *Financial Analysis 2014* reports. *Volume One*, released in May 2015, focused on the financial health of Pennsylvania's general acute care (GAC) hospitals. This report, *Volume Two* presents financial information on Pennsylvania's ambulatory surgery centers (ASCs). *Volume Three*, to be released later this year, will focus on non-GAC (rehabilitation, long-term acute, psychiatric and specialty) hospitals.

The reporting year for the ASCs in *Volume Two* is based on each facility's fiscal year that ended during 2014. The fiscal year for the majority of ASCs was calendar year ending December 31, 2014. For those facilities that do not utilize a calendar year, the fiscal year typically ended on June 30, 2014.


Information contained in this report was derived from annual financial statements, supplemented with additional data, as well as quarterly ambulatory/outpatient procedure data supplied by each facility. Every reasonable effort has been made to ensure the accuracy of the information contained herein. Each facility had the opportunity to review its data and to make corrections. The responsibility for data accuracy lies with the individual facility.

#### Pennsylvania's ASCs


The Commonwealth of Pennsylvania licenses ambulatory surgery centers (ASCs) that offer medical and/or surgical outpatient services to the public.

There were 288 licensed ASCs in Pennsylvania that operated during at least some portion of fiscal year 2014 (FY14). There were 285 ASCs that operated during the prior year. Seven ASCs opened, and four closed between reporting periods. Of the facilities that opened; two were in Region 1, one in Region 6, three in Region 8, and one in Region 9. Of the facilities that closed; one was in Region 6, two in Region 7, and one in Region 9.

Between FY05 and FY14, the number of ASCs in Pennsylvania grew by 111 facilities (Figure 1), with the largest increase (18%) occurred in FY06. The number of ASCs increased from 177 ASCs in



FY05 to 209 ASCs in FY06. The greatest concentration of growth occurred in Region 8 – Bucks, Chester, Delaware, and Montgomery counties (Figure 2).



The analysis for FY14 and the individual ASC tables in this report is based on data collected from 268 ASCs; 20 ASCs that did not submit complete data are not included in this report.

#### **ASC Income**

ASCs need positive income levels (total margin) to operate effectively. Those that have a negative total margin, or deficit, are not receiving sufficient revenue to pay all of their expenses.

ASCs need to earn sufficient income to improve their facilities and equipment. Such improvements are necessary to replace worn out or obsolete equipment, keep pace with changes in medical technology, and meet a community's changing health care needs.

The level of income needed to keep an ASC financially healthy will be different for each individual facility. The precise amount of income an ASC needs depends on several factors, including, but not limited to: the condition of its equipment, the

amount of debt, the mix of care provided by the ASC, the level of payment risk, and the current and future needs of the market an ASC serves.

## **Operating Margin & Total Margin**

ASC income may be expressed as either operating margin or total margin.

Operating margin reflects the percent of operating revenue remaining after all operating expenses are paid (operating income). A positive operating margin indicates operating revenues exceed operating expenses. Alternatively, a negative operating margin indicates that revenues are not covering costs.

Total margin reflects the percent of net income, which is both operating income and income from all other sources, (non-operating income, if any).


Total margin reveals the composite financial health of a facility during the year. If total margin is negative, the ASC is losing money after all sources of revenue and income have been considered.

The statewide operating margin for ASCs in FY14 is 25.56% and statewide total margin is 25.77% (Table 1). As a group, the ASCs located in Region 6, northeastern Pennsylvania, reported the highest operating and total margins in the state during FY14 of 40.16% and 40.31%, respectively. ASCs in Region 1, southwestern Pennsylvania, reported the lowest operating margin of 14.07% and lowest total margin of 14.16% in the state during FY14.

Operating and total margins for ASCs do not always reflect compensation to the physician owners or reflect the payment of income tax expenses.

Physician owners of surgery centers may receive all or part of their compensation as a distribution of net income instead of salaries or fees. Consequently, such distributions are not reported as an operating expense; if they were, that would reduce operating and total margins.

In addition, the majority of ASCs are limited liability partnerships or Sub-Chapter S corporations



and therefore, are not subject to income taxes, which generally are paid as personal income tax by the owners. Consequently, the total margin for most forprofit ASCs does not reflect income tax expense.

## **Statewide Margins**

Statewide the average operating and total margins for ASCs increased from FY13 to FY14 (Figure 3). The average operating margin increased to 25.56% in FY14 from 24.94% in FY13. The average total margin increased to 25.77% in FY14 from 25.13% in FY13.

The statewide average operating and total margins for ASCs are similar because ASCs realize only a small amount of non-operating income.

Eighty-five percent (227) of the reporting ASCs operated as a for-profit facility during FY14. The remaining 15% (41) operated as a non-profit facility.

The 3-year average statewide total margin for ASCs during FY14 is 25.93%. The statewide average operating and total margins for ASCs have only changed marginally over the past seven fiscal years, FY08 to FY14.

## STATEWIDE UTILIZATION

## Statewide Outpatient Visits & Revenue


Pennsylvania's ASCs reported 1 million total outpatient visits during FY14 and \$1.2 billion total net outpatient revenue (Table 2). The slight decrease (2.1%) in the number of outpatient visits reported by ASCs during FY14, combined with the 3.8% increase in net outpatient revenue, resulted in an average revenue per visit of \$1,149 during FY14; a 6.0% increase over FY13 figure of \$1,084 (Figure 4).

There is a wide variation in the level of resources provided per visit among ASCs and hospital outpatient departments (HOPDs). For example, a patient may receive care as a series of visits comprised of relatively short treatments (e.g., psychotherapy) in a hospital outpatient setting, while a patient at an ASC may be subject to an entire surgical procedure during a single visit. As a group, ASCs provide a variety of outpatient services at varying levels of resource intensity; however, on an individual basis, ASCs specialize in surgical procedures, e.g., endoscopy, laser surgery, ophthalmology and spine care.

## **Statewide Outpatient Procedures**

During FY14, ASCs and general acute care

(GAC) hospitals HOPDs combined submitted 3.2 million outpatient records to PHC4 (Table 3).

ASCs performed 28.8%, or 929,192, of these outpatient procedures. In FY10, ASCs performed 31.6% or 907,431 of the total 2.9 million outpatient procedures. The percent of procedures performed at ASCs remained relatively the same over the past five fiscal years, FY10 to FY14.


During FY14, the net growth in the number of outpatient procedures at ASCs and GAC HOPDs combined increased 4.6% over FY13. The number of outpatient procedures at ASCs decreased 1.5%, and the number of outpatient procedures at GAC HOPDs increased 7.3% in FY14.

## Statewide Payer Mix

The payer mix for outpatient procedures performed at ASCs is similar to GAC HOPDs (Figure 5). The greatest differences between the two are the proportion of procedures covered by Medical Assistance (MA) and commercial health insurance plans. During FY14, MA was the payer for 5.3% of outpatient procedures at ASCs, compared to 12.0% at GAC HOPDs. Commercial health insurance plans

covered 49.8% of outpatient procedures at ASCs, compared to 41.7% at GAC HOPDs.

In FY14, the mean age for patients undergoing an outpatient procedure at an ASC was 57.4 years, compared to 53.3 years for patients at GAC HOPDs.


The tables on the following pages provide specific financial data for 268 ASCs that reported complete data for FY14. The ASCs are arranged by the PHC4's nine regions.

Included in these tables are operating and total margins for each individual ASC. Each ASC's corresponding operating income, total income, and total operating revenue can be obtained on PHC4's website, <a href="www.phc4.org">www.phc4.org</a>. (Note: Other operating revenue must be included with net patient revenue to calculate the operating income that is used to calculate operating margin.)

Statewide and regional averages for ASCs are presented in the first rows of each table. The regional averages that are expressed as a percentage (e.g., "3-Year Average Change in NPR" and "Operating Margin") are calculated as if the entire region was a single reporting entity. For example, the regional average operating margins are calculated by adding operating income and operating revenue for all ASCs within the region. The regional total operating income is divided by the regional total operating revenue to yield a regional average operating margin.

#### **EXPLANATION OF TERMS & MEASURES**

3-year Average Change in Net Patient Revenue (NPR) or Total Operating Expenses (TOE): The average annual change in the facility's NPR or TOE that occurred from the end of FY11 through FY14.

 $(((NPR_{14} - NPR_{11}) / NPR_{11}) / 3)$  or  $(((TOE_{14} - TOE_{11}) / TOE_{11}) / 3)$ 

**3-year Average Total Margin:** The average total margin realized by the facility during FY12 through FY14.

( $\Sigma$  revenue over expenses <sub>14, 13, 12</sub> /  $\Sigma$  total revenue <sub>14, 13, 12</sub>)

Ambulatory Surgery Center (ASC): A licensed facility by the Pennsylvania Department of Health that provides specialty or multi-specialty surgical care to patients who do not require overnight hospitalization, but require medical supervision following a procedure. An ASC does not include individual or group practice offices of private physicians or dentists.

Commercial Third-Party Payers: Commercial insurers encompass all indemnity and managed care health insurance plans, including Blue Cross and Blue Shield plans, and hospital and health care system plans. Government-funded programs, such as Medicare managed care, are not included even if a commercial insurer administers the program.

**Net Patient Revenue (NPR):** Net patient revenue reflects revenue for patient care only and does not include revenue from other operations, such as the cafeteria, parking, rent, research and educational activities. Revenue from those operations is included in total operating revenue. NPR may include retroactive adjustments from third-party payers for care provided during a previous fiscal year.

Other Third-Party Payers: Third-party payers other than health insurance companies and managed care organizations. These include direct payments by employers or associations, auto insurance, workers' compensation, and government programs (other than Medicare and Medical Assistance).

**Operating Income:** The amount by which total operating revenue exceeds total operating expenses.

(total operating revenue – total operating expenses)

**Operating Margin:** The ratio of operating income to total operating revenue. This measure places operating income in perspective with the volume of business realized by the facility.

(operating income / total operating revenue)

**Outpatient Visits:** The number of visits to the surgery center or an individual outpatient department of the hospital during the fiscal year.

**Total Margin:** The ratio of total income to total revenue. This measure puts income from all sources in perspective with all revenues received by a facility.

(revenue over expenses / total revenue)

**Total Net Income (Revenue over Expenses):** Total net income reflects the sum of operating income and non-operating income. Total net income may also include an extraordinary item.

**Total Operating Expenses (TOE):** All costs associated with operating the entire facility such as salaries, professional fees, supplies, depreciation, interest, and insurance. The acquisition of durable equipment and other property are not considered expenses and are reflected on the facility's balance sheet as assets. However, the cost to finance equipment (interest) as well as the depreciation, operation and maintenance costs of capital equipment are operating expenses.

Total Operating Revenue (TOR): All revenues allocated by the facility to meet operating expenses. Includes revenue sources such as net patient revenue, investment income, contributions, and revenue from other operations (e.g., cafeteria, parking, rent, research and educational activities). Individual facilities may also allocate investment income, contributions, etc., as non-operating income.

**Total Revenue:** Operating revenue plus non-operating income. The non-operating income component typically includes unrestricted contributions, investment income, and net investment gains and losses on marketable securities.
