

## **About PHC4**

The Pennsylvania Health Care Cost Containment Council (PHC4) is an independent state agency charged with collecting, analyzing, and reporting information that can be used to improve the quality and restrain the cost of health care in the state. It was created in the mid-1980s when Pennsylvania businesses and labor unions, in collaboration with other key stakeholders, joined forces to enact market-oriented health care reforms. As a result of their years of effort, the General Assembly passed legislation (Act 89 of 1986) creating PHC4.

The primary goal is to empower purchasers of health care benefits, such as businesses and labor unions, as well as other stakeholders, with information they can use to improve quality and restrain costs. Nearly 100 organizations and individuals annually utilize PHC4's special requests process to access and use data. More than 840,000 public reports on patient treatment results are downloaded from the PHC4 website annually. Today, PHC4 is a recognized national leader in public health care reporting.

It is governed by a 25-member board of directors representing business, labor, consumers, health care providers, insurers, and state government.

## INTRODUCTION

#### Introduction

On an annual basis, the Pennsylvania Health Care Cost Containment Council (PHC4) produces a series of reports measuring the financial health of Pennsylvania's hospitals and ambulatory surgery centers.

This is the second volume of a three-volume series. *Volume One*, released in May 2013, focused on the financial health of Pennsylvania's general acute care (GAC) hospitals. This report, *Volume Two*, concentrates on Pennsylvania's ambulatory surgery centers (ASCs). *Volume Three*, to be released later this year, will focus on rehabilitation, psychiatric, state psychiatric, long-term acute care, and specialty (non-GAC) hospitals. *Volume Two* provides a financial perspective on the outpatient care provided by licensed ambulatory surgery centers in the Commonwealth.

The reporting year for the ASCs in *Volume Two* is based on each facility's fiscal year that ended during 2012. The fiscal year for the majority of ASCs was the calendar year ending December 31, 2012. For those facilities that do not utilize a calendar year, the fiscal year typically ended on June 30, 2012.

The information in this report was derived from annual financial statements supplemented with additional data, as well as quarterly ambulatory/outpatient procedure data supplied by each facility. Every reasonable effort has been made to ensure the accuracy of the information. Each ASC has had the opportunity to review their data and make changes, if necessary. The ultimate responsibility for accuracy lies with the individual ASC.

## **Key Findings**


- The number of ambulatory surgery centers (ASCs) in Pennsylvania increased by 10 in fiscal year 2012 (FY12) to 281.
- The average operating and total margins for ASCs statewide increased slightly from FY11 to FY12, with the average operating margin increasing to 25.83% (from 24.94%) and the total margin increasing to 27.01% (from 25.12%).
- ASCs reported 1.1 million outpatient visits and \$1.1 billion in net outpatient revenue during FY12.
- The number of procedures at ASCs increased 0.7% in FY12.
- Commercial health insurance plans covered 51.4% of outpatient procedures at ASCs during FY12.

## **Ambulatory Surgery Centers**

During fiscal year 2012 (FY12), there were 281 ambulatory surgery centers (ASCs) operating in Pennsylvania.<sup>1</sup> The number of ASCs in Pennsylvania increased by ten in FY12. Between FY11 and FY12, 15 ASCs opened and five closed. Of the facilities that opened; five were in Region 1; one in Region 2; one in Region 3; one in Region 4; one in Region 5; one in Region 6; four in Region 8; and one in Region 9. Of the facilities that closed; two were in Region 1; two were in Region 5; and one was in Region 8.

Figures 1 and 2 illustrate the growth in the number of ASCs in Pennsylvania from FY03 to FY12. Between FY03 and FY12, the number of ASCs in Pennsylvania grew by 154 facilities, with the largest increase (28%) occurring in FY04. Over the same time period, the greatest concentration of growth occurred in Region 8—Bucks, Chester, Delaware and Montgomery counties (see Figure 1).

#### FIGURE 1 Number of Ambulatory Surgery Centers, FY03 & FY12 by Region



The analysis for FY12 and the individual ASC tables in this report is based on data collected from 269 ASCs; twelve ASCs did not submit complete data and their data is not included in this report.

Statewide and regional averages that are expressed as a percentage (e.g., operating margin)

in this report were calculated as if the entire group (state or region) were a single reporting entity. For example, the regional average operating margins were calculated by dividing the sum of operating income for all ASCs in the region and the sum of total operating revenue for all ASCs in the region.





#### **Operating and Total Margins**

The average operating and total margins for ASCs statewide increased slightly from FY11 to FY12, with the average operating margin increasing to 25.83% (from 24.94%) and the total margin increasing to 27.01% (from 25.12%). The average statewide operating and total margins for ASCs have changed only marginally over the past four fiscal years, FY08 to FY12 (see Figure 3).

The statewide average operating and total margins for ASCs are similar because ASCs realize only a small amount of non-operating income. Eighty-seven percent (233) of reporting Pennsylvania ASCs operated as for-profit facilities in FY12. The remaining 13% (36) operated as nonprofit facilities. Operating and total margins for ASCs do not always reflect compensation to the physician owners or reflect income tax expenses.

Physician owners of surgery centers may receive all or part of their compensation as a distribution of net income instead of salaries or fees. Consequently, such distributions are not reported as an operating expense; if they were, that would reduce operating and total margins.

In addition, the majority of ASCs are limited liability partnerships or Sub-Chapter S corporations and therefore, are not subject to income taxes, which generally are paid as personal income tax by the owners. Consequently, the total margin for most for-profit ASCs does not reflect income tax expenses.



#### FIGURE 3 Statewide Average Operating and Total Margins for Ambulatory Surgery Centers by Fiscal Year




#### **Outpatient Visits and Revenue**

Pennsylvania's ASCs reported 1.1 million total outpatient visits during FY12 and \$1.1 billion total net outpatient revenue (Table 3). The increase (3.1%) in the number of outpatient visits reported by ASCs during FY12, combined with the 6.9% increase in net outpatient revenue, resulted in an average revenue per visit of \$1,036 during FY12, a 3.7% increase over the FY11 figure of \$999.

There is a wide variation in the level of resources provided per visit among ASCs and

hospital outpatient departments (HOPDs). For example, a patient may receive care as a series of visits comprised of relatively short treatments (e.g., psychotherapy) in a hospital outpatient setting, while a patient at an ASC may be subject to an entire surgical procedure during a single visit. As a group, ASCs provide a variety of outpatient services at varying levels of resource intensity; however, on an individual basis, ASCs specialize in surgical procedures, e.g., endoscopy, laser surgery, ophthalmology, and spine care.



#### **Outpatient Procedures**

During FY12, there were 3 million outpatient procedures<sup>1</sup> performed at ASCs and general acute care (GAC) HOPDs combined (Figure 5 and Table 4). ASCs performed 31.5% or 931,229 of these procedures. In FY00, ASCs performed 10.2% or 164,690 of the total 1.6 million outpatient procedures performed in Pennsylvania. The percent of procedures performed at ASCs has remained relatively the same over the past three fiscal years, FY10 to FY12.

There was an 82.8% growth in the total number of outpatient procedures performed at ASCs and outpatient departments of GAC hospitals between FY00 and FY12; 57.3% of that increase occurred at ASCs. During FY12, the net growth in the number of outpatient procedures performed at GAC HOPDs and ASCs combined increased 3.7% over FY11 numbers. The number of outpatient procedures performed at GAC HOPDs increased 5.2%, and the number of procedures at ASCs increased 0.7% in FY12. In FY11, the number of procedures at the ASCs increased 2.5% from the number performed in FY10.

# PAYER MIX

#### **Payer Mix**


Figure 6 presents the payer mix for outpatient procedures performed at ASCs compared to GAC HOPDs. The greatest differences between the two types of facilities are the proportion of procedures covered by Medical Assistance (MA) and commercial health insurance plans. During FY12, MA was the payer for 5.1% of outpatient procedures at ASCs, compared to 12.0% at GAC HOPDs. Commercial health insurance plans covered 51.4% of outpatient procedures at ASCs, compared to 43.7% at GAC HOPDs.

The higher percentage of Medicare-based revenue received by ASCs is consistent with the difference in the average patient age at ASCs and GAC HOPDs. In FY12, the mean age for patients undergoing an outpatient procedure at an ASC was 56.9 years, compared to 52.9 years for patients at GAC HOPDs.

## Individual Ambulatory Surgery Center Data

The individual ASC data tables on the following pages are based on data collected from 269 ASCs; twelve ASCs did not submit complete data and their data is not included in this report. The facilities listed in the tables are arranged according to region.

Statewide and regional averages for ASCs are presented in the individual facility tables. Averages expressed as a percentage (e.g., operating margin) were calculated as if the entire group (state or region) were a single reporting entity. For example, the regional average operating margins were calculated by dividing the sum of operating income for all ASCs in the region and the sum of total operating revenue for all ASCs in the region.

The FY12 operating and total margins for each individual facility are included in these tables. Each facility's corresponding operating income, total income, and total operating revenue, expressed in dollars, can be found on PHC4's website at www.phc4.org. (Note: Other operating revenue must be included with net patient revenue to calculate the operating income that is used for operating margin.)

#### **Explanation of Terms and Measures**

**3-year Average Change in Net Patient Revenue (NPR) or Total Operating Expenses (TOE):** The average annual change in the facility's NPR or TOE that occurred from the end of FY09 through FY12.

**3-year Average Total Margin:** The average total margin realized by the facility during FY10 through FY12.

( $\Sigma$  revenue over expenses 12, 11, 10 /  $\Sigma$  total revenue 12, 11 10)

**Ambulatory Surgery Center (ASC):** A licensed facility by the Pennsylvania Department of Health that provides specialty or multispecialty surgical care to patients who do not require overnight hospitalization, but require medical supervision following a procedure. An ASC does not include individual or group practice offices of private physicians or dentists.

**Commercial Third-Party Payers:** Commercial insurers encompass all indemnity and managed care health insurance plans, including Blue Cross and Blue Shield plans, and hospital and health system plans. Government-funded programs, such as Medicare managed care, are not included, even if a commercial insurer administers the program.

**Long-Term Acute Care (LTAC) Hospital:** A licensed acute care hospital by the Pennsylvania Department of Health that provides medical services for patients that require extended lengths of acute care inpatient stay.

**Net Patient Revenue (NPR):** Net patient revenue reflects revenue for patient care only and does not include revenue from other operations, such as the cafeteria, parking, rent, research and educational activities. Revenue from those operations is included in total operating revenue. NPR may include retroactive adjustments from third-party payers for care provided during a previous fiscal year.

**Other Third-Party Payers:** Third-party payers other than health insurance companies and managed care organizations. These include direct payments by employers or associations, auto insurance, workers compensation, and government programs (other than Medicare and Medical Assistance).

**Operating Income:** The amount by which total operating revenue exceeds total operating expenses.

(total operating revenue – total operating expenses)

**Operating Margin:** The ratio of operating income to total operating revenue. This measure places operating income in perspective with the volume of business realized by the facility.

(operating income / total operating revenue)

**Outpatient Visits:** The number of visits to the individual outpatient department of the hospital or surgery center during the fiscal year.

**Psychiatric Hospital:** A licensed institution certified by the Pennsylvania Department of Welfare to operate as a hospital that provides short-term acute psychiatric services on an inpatient basis. Psychiatric hospitals may also offer long-term residential and outpatient programs. Acute psychiatric care is rendered in response to severe psychiatric conditions requiring intensive or extensive intervention to bring the patient's symptoms under control.

**Rehabilitation Hospital:** A licensed inpatient facility by the Pennsylvania Department of Health, which is operated for the primary purpose of assisting in the physical rehabilitation of persons through an integrated program of medical and other services. Rehabilitation hospitals may also offer outpatient services.

**Specialty Hospital:** A licensed facility by the Pennsylvania Department of Health that provides specific types of inpatient and outpatient settings of care, such as drug and alcohol.

**Total Margin:** The ratio of total income to total revenue. This measure puts income from all sources in perspective with all revenues received by a facility.

(revenue over expenses / total revenue)

**Total Net Income (Revenue over Expenses):** Total net income reflects the sum of operating income and non-operating income. Total income may also include an extraordinary item, such as the gain or loss from the sale of securities.

**Total Operating Expenses (TOE):** All costs associated with operating the entire facility, such as salaries, professional fees, supplies, depreciation, interest, and insurance. The acquisition of durable equipment and other property are not considered expenses and are reflected on the facility's balance sheet as assets. However, the cost to finance equipment (interest) as well as the depreciation, operation and maintenance costs of capital equipment are operating expenses.

**Total Operating Revenue (TOR):** All revenues allocated by the facility to meet operating expenses. Includes revenue sources such as net patient revenue, investment income, contributions, and revenue from other operations (e.g., cafeteria, parking, rent, research and educational activities). Individual facilities may also allocate investment income, contributions, etc., as non-operating income.

**Total Revenue:** Operating revenue plus non-operating income. The non-operating income component typically includes unrestricted contributions, investment income, and net investment gains and losses on marketable securities.
